The above course is open to all persons in Queensland seeking Weapons Act licence/s who are eligible to obtain such licence/s. Given the nature of the course, the requirement to handle firearms and the relevant legislation, Lennon Training have the below process in place.

Eligibility review.

Complete the attached Form 33. The statements are to be answered Yes / No. It is an immediate breach of law for false or misleading information.

The **relevant period** of time means the five (5) year period immediately before the day the person applies for the issue or renewal of the licence
