

## Overview of the RCC application

This particular RCC process is intended for those underground mine workers who have **already held** the Std 11 Surface & Underground qualification and by their training record they can demonstrate that they have been employing those skills in the interim since first obtaining the qualification.

Our evidence requirements for a person to be eligible to apply for this RCC process are described in two parts:

- ⇒ Part A will focus on 6 RII units that need site evidence and Supervisor endorsements
- ⇒ Part B will focus on the 7th unit ERR203 that will require mine site training record (or equivalent) showing the applicant has completed two years' underground work within the previous five (5) years

If the information supplied is satisfactory, you will be required to attend our training centre for a maximum of four hours and complete the following

- ⇒ A written theory assessment relating to TARP's, authorisations, reading Statutory report and panel inspection board etc
- ⇒ In the smoke filled gallery, demonstrate the donning of a self-rescuer and then change over to a CABA unit

## Time and Fees involved at Lennon Training

If the above sufficiently demonstrates competence, the total cost per person is \$571.40 (includes \$3.10 gst). A Statement of Attainment will be issued for the above mentioned RII units in partial completion of RII20315 Certificate II in UG Coal Mining.

Alternative options & fees will be discussed if application has insufficient evidence.

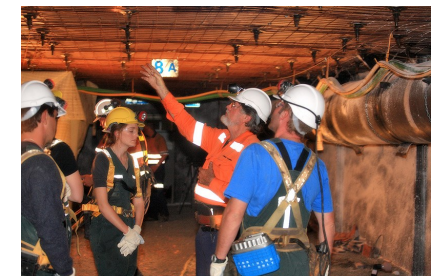
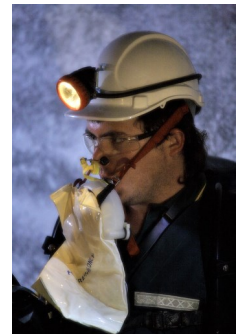
